In continuation of the Ministry's letter of even no. dated 25.08.2017 (copy enclosed), wherein all the State Governments have been requested to implement the action plan for counselling and admission in various courses of MD/MS for the academic session 2017-18, the following has been decided and is conveyed for information and compliance:

- i. With regard to the condition mentioned at Sl. No. 8 (5) - Mode of Admission, of IMCC (Post Graduation Ayurveda Education) Regulations 2016, the criteria of 50% qualifying marks for admission in Ayurveda Stream has been waived off to ensure equality on qualifying criteria related to cut-off marks for admission as in the case of Homoeopathy, Siddha and Unani streams.
 - ii. With regard to condition mentioned at Sl. No. 1.0 (1.1) of ELIGIBILITY CRITERIA FOR AIAPGET 2017, the last date of completion of the internship shall be on/or before the cut off date of admissions (i.e. 30th September 2017).

Therefore, you are requested to prepare your own Common Merit List in light of the applicable rules, regulations, reservation policy & other criteria prevalent in respective State/UT for further course of action for counselling and admission in various courses of MD/MS for the academic session 2017-18 and display on the website.


